(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). The Offeror would claim an exemption from the withholding by using the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, available via the internet at www.irs.gov/w14. (2) The Offeror shall submit with its offer the IRS Form W-14. If the IRS Form W-14 is not submitted with the offer, exemptions will not be applied to any resulting contract and the Government will withhold a full 2 percent of each payment.

(f) If the Offeror selects “is” in paragraph (d)(1) and “partial or no exemption” in paragraph (d)(2) of this provision, the Offeror will be subject to withholding in accordance with the clause at FAR 52.229-12, Tax on Certain Foreign Procurements, in any resulting contract.

(g) A taxpayer may, for a fee, seek advice from the Internal Revenue Service (IRS) as to the proper tax treatment of a transaction. This is called a private letter ruling. Also, the IRS may publish a revenue ruling, which is an official interpretation by the IRS of the Internal Revenue Code, related statutes, tax treaties, and regulations. A revenue ruling is the conclusion of the IRS on how the law is applied to a specific set of facts. I. GENERAL INFORMATION

The United States Consulate in Surabaya requires professional services and contractor cost proposals to perform landscape irrigation improvement at Consulate compound as described in this statement of work.

II. SAFETY & SPECIAL INSTRUCTIONS

SAFETY: Safety is the highest priority on this projects. The contractor shall direct all the workers under to work safely. Regular safety meetings shall be held among on-site personnel and safety concerns shall be brought to the attention of the Post Safety and Health Officer (PSHO) and/or the COR. The contractor is expected to provide all required PPE for the workers to work safely. (LOTO) lock out tag out is to be strictly enforced when working on electrical power.

The Contractor shall meet and compliant with the US safety standard listed below:

- 1) Federal Acquisition Regulation (FAR) *52.236-13 Accident Prevention*
- 2) Dept of State Acquisition Regulations (DOSAR) Accident Prevention clause *652.236-70 Additional Safety Measures*

Those safety standards are attached in this statement of work.

The contractor must submit an effective safety plan (include Personal Protective Equipment/PPE) and develop Activity Hazard Analyses (AHA) as necessary to address hazards during the service. The safety plan and AHA must be enclosed in the quotation.

III. SCOPE OF WORK

Contractor shall provide supervision, material, labor, tools and equipment to do improvement of landscape irrigation in U.S. Consulate General Surabaya. 3. Contractor to serves four (4) months warranty for the service that they provided and responsible for replacement during warranty period.
4. Procedure of site preparation
 - a. The contractor shall be knowledgeable of a particular subject within the scope of work.
 - b. Located where the broken underground lawn irrigation pipe to be restored, inspect the irrigation valve station condition before conducting the work. Closed the irrigation valve and put the signage "Under Maintenance"
 - c. The contractor shall provide as built drawing the irrigation pipe that have been restored.
 - d. Cleared material shall be totally removed from project site and properly disposed of the property.
5. Procedure to install new sprinkler
 - a. Carefully dig soils around irrigation pipe, valve connector, and sprinkler that will need to be restored.
 - b. Clean all pipe and sprinkler thread connection from soil/root/debris, ensure all underground plumbing fittings are in a good condition.
 - c. Unscrew the hose connection, check thread riser and the other connectors. Replace with proper fitting thread and length if its broken. Dig more soil if deemed necessary until all the broken pipeline and its connection are observed.
 - d. Measure length of the irrigation pipeline will be installed based on the drawing given by COR.
 - e. Install the new irrigation pipe, oversee elevation of the ground, connect them to the underground riser connection, ensure the thread is clean, always apply Teflon tape for making any new pipe connections.

10. The contractor is responsible to rectify any damage cause by this project.

IV. WORK RESTRICTIONS

Protection

Contractor will keep the project area cleaned and remove debris from project site at the end of each day. Loitering around the project site is not permitted. Contractor will provide mixture box to mix mortar or concrete to prevent damage to the mixing site.

Contractor shall be responsible for protecting U.S. Government property on site from damage, scratch, dust, water, fire or theft, and ensure caution to prevent accidents caused by various work. Install proper warning signs and protection to the site. Contractor is responsible to repair any damage caused by the implementation of the work. Contractor will do general rewiring and re-piping if required as a result of the various works.

Contractor's operations may not cause disruption of site activities. Contractor's operations shall not generate disagreeable environmental effects, including the emission of noise, fumes, or other emanations. Construction debris shall be monitored at all times. Visual or audible disturbances shall be kept to a minimum, and any work progress, which might cause such disturbances shall.

V. ACCESS TO SITE

The contractor shall permit the facilities manager and COR or any officer authorized by the COR to have access to the work at all times during the execution of work.

The contractor superintendent shall meet daily with the COR (unless waived by the COR) to review progress and plans

VI. CONDITIONS

1. Contractor to inspect and measure the project thoroughly before submitting the bid. Project inspection and measurement must be done after the site meeting unless determined otherwise. No chance for another inspection and measurement will be given to any contractor between the site meeting and bid submission time frame, unless stated otherwise. Submission

- of the bid is an agreement by the contractor to carry out the project in a turnkey condition.
2. Drawings and specifications are used as a general guide only. Anything not mentioned in the specifications or drawings but related to common requirements for completion of the project in a satisfactory manner will be determined by the COR at the site meeting and becomes part of the contract.
 3. After the site meeting and before submitting the bid, the contractors can ask clarification about the project by submitting a written question to Contracting Officer. The answer to the question will be distributed to all contractors invited to the site meeting and becomes part of the contract.
 4. After the site meeting and commencement of the project, any unforeseen conditions that arise to ensure proper completion of the project will become the contractor's responsibility at no additional cost to the U.S. Government, unless justified otherwise or caused by the embassy.

VII. PRICE AND PAYMENT PROCEDURES

The Contractor shall complete this project according to all specifications and requirements stated in this contract. The price listed below shall include all materials, labors, equipment, tools, transportation, insurance, overhead, profit, and all expenses. The Contract Type shall be “Firm-Fixed Price”.

VIII. PROJECT MEETINGS

The Embassy or the contractor may request a meeting (either on-site or off-site) to clarify any part of this contract. The contractor will keep minutes of every meeting and provide written copies (within two working days) to the COR for approval.

IX. SCHEDULING OF WORK

Contractor shall schedule work with COR prior to commencement.

X. SECURITY PROCEDURES

Security Requirements and Procedures for Contractors

Contractors who require access to any of the Embassy offices or facilities are required to comply with the following security procedures:

Coordinate with RSO to have all workers that require access to the house report for fingerprints so criminal record checks can be conducted. All workers must bring a valid identification card. Criminal records checks typically take approximately one month to complete. Thus, it is important to have contract workers report as early as possible (within 24 hours after the award of the contract) to RSO to start the process.

Upon successful completion of a criminal record check contractors shall submit working pass request to the RSO thru the COR which will allow them to access the house.

Unsuitable Workers

Upon the request of the COR, the contractor shall remove any person employed by him who, in the opinion of the COR, is incompetent or has conducted himself improperly. Workers who are found to conduct themselves in an improper manner, such as urination outside the approved toilets, foul language, improper behavior, and other such acts, shall be immediately barred from site. The contractor shall not permit a person who has been removed to return to the work site.

XI. BUILDING CODES

Perform all works in accordance with the Indonesia building codes (Electrical, Plumbing and other codes that pertain to trades involved in this project). In no instance shall a standard identified or established in this section be reduced without written permission from the COR.

XII. PERMITS

Contractor shall be responsible for any permit and administration cost required to perform and complete the project.

XIII. DEFINITIONS

“Install,” means, “provide and install” unless stated otherwise. “Repair,” means, “restores to proper and satisfactorily condition using the minimum of the same material as the existing with equal or exceeds quality.” “Upgrade,” means, “correct the existing condition and replace all with new material per U.S. Embassy standard” unless stated otherwise. “Remove,” means, “dismantle and completely remove all materials specified including other materials required to attach it to the building structure or roof or ceiling or wall or soil” unless stated otherwise.

XIV. QUALITY ASSURANCE

Quality Control

Maintain quality control over suppliers, manufacturers, products, services, site conditions, and workmanship to produce work of specified quality. Examine each phase of work and have defective conditions corrected before starting subsequent operations which include cover, or are dependent upon, work in question.

XV. CONSTRUCTION AIDS

Temporary ladders, scaffolds, hoists:

Furnish and maintain temporary ramps, scaffolds, or hoists as required for proper execution of work. Such apparatus, equipment, and construction shall meet requirement of applicable local safety and labor laws.

Storage and Handling Materials/Equipment/Tools:

Special care should be given to handling and storing materials/equipment/tools. The ownership of the items is passed from the contractor only upon acceptance by the COR. Equipment/tools not accepted by the COR is the contractor’s sole responsibility.

XVI. EXECUTION AND CLOSEOUT REQUIREMENTS

Final Completion

After completion of the work, the contractor shall make an appointment with COR for inspection and final acceptance with the signature of COR. The work site and related areas must be in a clean and tidy condition.

ATTACHMENT 1

Federal Acquisition Regulation (FAR) 52.236-13 Accident Prevention

(a) The Contractor shall provide and maintain work environments and procedures which will (1) safeguard the public and Government personnel, property, materials, supplies, and equipment exposed to Contractor operations and activities; (2) avoid interruptions of Government operations and delays in project completion dates; and (3) control costs in the performance of this contract.

(b) For these purposes on contracts for construction or dismantling, demolition, or removal of improvements, the Contractor shall –

- 1) Provide appropriate safety barricades, signs, and signal lights;
- 2) Comply with the standards issued by the Secretary of Labor at 29 CFR part 1926 and 29 CFR part 1910; and
- 3) Ensure that any additional measures the Contracting Officer determines to be reasonably necessary for the purposes are taken.

(c) If this contract is for construction or dismantling, demolition or removal of improvements with any Department of Defense agency or component, the Contractor shall comply with all pertinent provisions of the latest version of U.S. Army Corps of Engineers Safety and Health Requirements Manual, EM 385-1-1, in effect on the date of the solicitation.

(d) Whenever the Contracting Officer becomes aware of any noncompliance with these requirements or any condition which poses a serious or imminent danger to the health or safety of the public or Government personnel, the Contracting Officer shall notify the Contractor orally, with written confirmation, and request immediate initiation of corrective action. This notice, when delivered to the Contractor or the Contractor's representative at the work site, shall be deemed sufficient notice of the noncompliance and that corrective action is required. After receiving the notice, the Contractor shall immediately take corrective action. If the Contractor fails or refuses to promptly take corrective action, the Contracting Officer may issue an order stopping all or part of the work until satisfactory corrective action has been taken. The Contractor shall not be entitled to any equitable adjustment of the contract price or extension of the performance schedule on any stop work order issued under this clause.

(e) The Contractor shall insert this clause, including this paragraph (e), with appropriate changes in the designation of the parties, in subcontracts.

Alternate I (NOV 1991). If the contract will involve (a) work of a long duration or hazardous nature, or (b) performance on a Government facility that on the advice of technical representatives involves hazardous materials or operations that might endanger the safety of the public and/or Government personnel or property, add the following paragraph (f) to the basic clause:

(f) Before commencing the work, the Contractor shall –

ATTACHMENT 2

DOSAR Accident Prevention clause 652.236-70 *Additional Safety Measures*

In addition to the safety/accident prevention requirements of [FAR 52.236-13](#), Accident Prevention [Alternate I](#), the contractor shall comply with the following additional safety measures.

(a) High risk activities. If the project contains any of the following high risk activities, the contractor shall follow the section in the latest edition, as of the date of the solicitation, of the U.S. Army Corps of Engineers Safety and Health manual, EM 385-1-1, that corresponds to the high risk activity. Before work may proceed, the contractor must obtain approval from the COR of the written safety plan required by [FAR 52.236-13](#), Accident Prevention [Alternate I](#) (see paragraph (f) of this clause), containing specific hazard mitigation and control techniques.

- (1) Scaffolding;
- (2) Work at heights above 1.8 meters;
- (3) Trenching or other excavation greater than one (1) meter in depth;
- (4) Earth-moving equipment and other large vehicles;
- (5) Cranes and rigging;
- (6) Welding or cutting and other hot work;
- (7) Partial or total demolition of a structure;
- (8) Temporary wiring, use of portable electric tools, or other recognized electrical hazards. Temporary wiring and portable electric tools require the use of a ground fault circuit interrupter (GFCI) in the affected circuits; other electrical hazards may also require the use of a GFCI;
- (9) Work in confined spaces (limited exits, potential for oxygen less than 19.5 percent or combustible atmosphere, potential for solid or liquid engulfment, or other hazards considered to be immediately dangerous to life or health such as water tanks, transformer vaults, sewers, cisterns, etc.);
- (10) Hazardous materials - a material with a physical or health hazard including but not limited to, flammable, explosive, corrosive, toxic, reactive or unstable, or any operations, which creates any kind of contamination inside an occupied building such as dust from demolition activities, paints, solvents, etc.; or
- (11) Hazardous noise levels as required in EM 385-1 Section 5B or local standards if more restrictive.

(b) Safety and health requirements. The contractor and all subcontractors shall comply with the latest edition of the U.S. Army Corps of Engineers Safety and Health manual EM 385-1-1, or OSHA [29 CFR part 1910](#) or [1926](#) if no EM 385-1-1 requirements are applicable, and the accepted contractor's written safety program.

(c) Mishap reporting. The contractor is required to report *immediately* all mishaps to the COR and the contracting officer. A “mishap” is any event causing injury, disease or illness, death, material

loss or property damage, or incident causing environmental contamination. The mishap reporting requirement shall include fires, explosions, hazardous materials contamination, and other similar incidents that may threaten people, property, and equipment.

(d) Records. The contractor shall maintain an accurate record on all mishaps incident to work [performed](#) under this contract resulting in death, traumatic injury, occupational disease, or damage to or theft of property, materials, supplies, or equipment. The contractor shall report this data in the manner prescribed by the contracting officer.

(e) Subcontracts. The contractor shall insert this clause, including this paragraph (e), with appropriate changes in the designation of the parties, in subcontracts.

(f) Written program. The plan required by paragraph (f)(1) of the clause entitled “Accident Prevention Alternate I” shall be known as the Site Safety and Health Plan (SSHP) and shall address any activities listed in paragraph (a) of this clause, or as otherwise required by the contracting officer/COR.

(1) The SSHP shall be submitted at least 10 working days prior to commencing any activity at the site.

(2) The plan must address developing activity hazard analyses (AHAs) for specific tasks. The AHAs shall define the activities being [performed](#) and identify the work sequences, the specific anticipated hazards, site conditions, equipment, materials, and the control measures to be implemented to eliminate or reduce each hazard to an acceptable level of risk. Work shall not begin until the AHA for the work activity has been accepted by the COR and discussed with all engaged in the activity, including the Contractor, subcontractor(s), and Government on-site representatives.

(3) The names of the Competent/Qualified Person(s) required for a particular activity (for example, excavations, scaffolding, fall protection, other activities as specified by EM 385-1-1) shall be identified and included in the AHA. Proof of their competency/qualification shall be submitted to the contracting officer or COR for acceptance prior to the start of that work activity. The AHA shall be reviewed and modified as necessary to address changing site conditions, operations, or change of competent/qualified person(s).
